The Role of the SSWG

Introduction

- 1. This Note and its appendices has been produced by the Council at the request of the independent Inspector appointed to examine the Tunbridge Wells Local Plan to set out the role of the Strategic Sites Working Group and provide some context to the Minutes of meetings held by the group. These are circulated alongside.
- 2. As set out in the <u>Strategic Sites Topic Paper</u> [CD 3.67, paragraphs 3.3 to 3.6], the Strategic Sites Working Group (SSWG) is a forum that facilitates collaborative working in the delivery of the two strategic sites. All members have agreed to work positively and proactively in moving the sites forward (albeit, notwithstanding an 'in principle' objection to the growth in Capel parish held by both Capel Parish Council, and from his appointment as Ward Member for Capel in May 2021, Cllr Patterson).

Establishment of the SSWG

3. The SSWG was established following an initial introductory meeting in July 2019. This was ahead of the Regulation 18 Draft Local Plan entering the Council's committee process. It set out the approach to proposed growth around the two strategic sites of Paddock Wood and east Capel, and Tudeley Village. All site promoters were invited to participate, along with a representative from associated community groups (Capel Parish and Paddock Wood Town Councils), Borough ward members, relevant neighbourhood planning groups, adjoining local planning authorities to the site (Tonbridge and Malling BC, and Maidstone BC) and other statutory consultees and infrastructure providers including Kent County Council (KCC) Highways, Education and Planning; National Highways (formerly known as Highways England), the Environment Agency, the Kent and Medway NHS Clinical Commissioning Group, Southern Water and Network Rail. A full list of group participants is attached at Appendix 1.

Frequency of meetings

- 4. Meetings have been held regularly; originally, from the formation of the group after the July 2019 meeting these were held bi-monthly (a three month gap between September to December 2019 as this period coincided with the Regulation 18 consultation). By mid 2020, meetings increased to monthly reflecting the pace of work being undertaken to inform the Regulation 19 Local Plan. It was around this time that the brief for the Masterplanning work for the Strategic Sites [included at Appendix 2 of the Topic Paper, CD 3.67] was being prepared and masterplanning work completed, referenced below with dates for information.
- 5. It is noted there are a couple of months where meetings didn't take place. There was a pause over December/ January 2021 whilst the Plan was taken through the committee cycle ahead of Regulation 19 consultation, and again in June 2020 and 2021 which coincided with the half term break when many members of the SSWG were taking leave.
- 6. Following the completion of the Regulation 19 consultation in June 2021, it was agreed at the SSWG that moving away from monthly meetings was appropriate and to focus on a series of smaller engagements and joint working, based on certain areas of delivery (i.e., drainage/ infrastructure delivery). The SSWG would be held every quarter or so to provide updates of these discussions. It was agreed and considered that this approach would expedite discussions on the delivery of the Strategic Sites whilst keeping the key stakeholders updated on key matters. It is worth noting that at this point bi-monthly meetings were offered to both Paddock Wood Town Council and Capel Parish Council, and the Council has sought to arrange these where possible. Monthly meetings are taking place with the Council's ward Members. Accordingly, updating of and engagement with the community representations has been maintained.
- 7. A schedule of meetings which have taken place since June 2021 is appended at Appendix 2. This identifies the SSWG meeting held, alongside separate meetings which each body (whether individually or combined) as marked in green on the tracker.

Purpose of the SSWG

8. The purpose of the SSWG, as set out in the Topic Paper [CD 3.67], was to bring together the key stakeholders and provide a round table forum to update and enable discussions on key items in progressing the strategic sites through the Local Plan and beyond. For example, members of the SSWG input into the brief for the Masterplanning work (via email on 2nd July 2020 ahead of finalisation and publication of the Tender on 7th July 2020. Comments were received and incorporated into the final tender document); were invited to the technical workshops for their appropriate disciplines and were given presentations on the emerging Masterplan and Infrastructure work which was prepared by David Lock Associates. The SSWG was also provided with presentations on the Council's active travel proposals for Paddock Wood and Tudeley Village, as set out in the draft Local Cycling and Walking Implementation Plan (LCWIP) [CD 3.115]. It also enabled all parties to be kept updated on the masterplan proposals being progressed by the Hadlow Estate for Tudeley Village.

Network of stakeholders, collaboration and outcomes

- 9. It is important to note, however, that these meetings did not comprise the only opportunity for discussions. Instead, it created a Strategic Sites network of all relevant stakeholders and provided a regular forum for updates, questions and input, where appropriate. This has facilitated further work under the DtC (i.e., outside of the SSWG) with partner organisations, for example as referred to in paragraphs 125, 141, 147 of the Hearing Statement [TWLP_001]. By way of two examples, a meeting was held with Southern Water on the drainage capacity within the Strategic Sites and planning for this growth in Southern Water's future business plan on 22 September 2021 [See CD 3.132C, Appendix I9] and regular discussions with the NHS CCG on the Strategic Sites took place [See CD 3.132c Appendix H13].
- 10. This ensured all key stakeholders are continually aware of the nature and scale of proposals to help all parties work collaboratively to deliver these sites (which ties in with paragraph 060 of the Planning Practice Guidance in terms of securing

- infrastructure delivery within the Strategic Sites). Through building this effective network, led by the Council, it provided an opportunity for stakeholders to raise, discuss and jointly work on key issues outside of the meeting with dedicated officers at the Council and vice versa.
- 11. As set out above, alongside the SSWG, there has been extensive discussions with key stakeholders to drive forward the strategic sites. This includes with infrastructure providers to determine infrastructure provision, the Environment Agency to discuss flooding matters, adjoining authorities to consider cross-boundary issues, and Network Rail to discuss future railway provision, where relevant. Schedules of all these meetings are within the Duty to Cooperate Statement Appendices [CD 3.132c]. The Council has also successfully been able to use the principles of the SSWG to set up other working group meetings feeding into the wider work sitting under the SSWG umbrella; for example, it was agreed at a recent drainage workshop with KCC, Upper Medway Integral Drainage Board and Environment Agency that a specific Tudeley Village and Paddock Wood workshop should be established, including members of both Capel Parish Council and Paddock Wood Town Council in attendance. The SSWG has established a positive climate for joint working amongst the key stakeholders which is being witnessed through various meetings outside of the SSWG itself.

Transparency

12. To confirm, from the outset it was agreed by all Members of the SSWG that meetings minutes should remain private and confidential. To facilitate open discussions, there may be occasions where developers are encouraged to relay information which is commercially sensitive. Minutes could be shared to anyone within the organisation in line with these terms. Alongside these confidential minutes, the Council have provided agreed summary notes for organisations to circulate more widely if appropriate.

TWBC Local Plan Inspector's request

13. Following the hearing session on 1st March, the SSWG members have agreed for the minutes to be issued to the Inspector to be made publicly available as part of the

	This was the first meeting of this group and so SB ran through housekeeping arrangements and asked for introductions from all of those present.	
	Post meeting note: these minutes should be read in conjunction with the letters sent to attendees of the meeting, ahead of the meeting.	
	Post meeting note: these minutes, discussions, and associated correspondence are not to be made public. TWBC will be providing information on the process and timescales for masterplanning as part of the exhibitions at in Capel and PW to be undertaken as part of the Regulation 18 consultation, with information provided on the TWBC website in due course. This will include detailing that this is being undertaken subject to the Draft Local Plan progressing as is, but if that changes, then there may be a need for the masterplanning process to adjust/cease.	
3	Presentation on the strategic policies in the Draft Local Plan by TWBC and questions	
	SB provided an update on the progress made on the Draft Local Plan and the timetable and some of the key headlines of the document. He also confirmed that the presentation slides would be sent out to all attendees following the meeting. ACTION : SB to circulate	SB to

slides. SB highlighted the key points of the strategic policies for Capel and Paddock Wood and Tudeley village and also ran through some of the key DM policies including those in relation to transport, parking standards, affordable housing, sustainable design and construction.

A number of guestions were raised as set out below;

- Query over social housing of the overall quantum of affordable housing SB stated that 40% for the rest of the borough but that additional work is to be carried out over the next 6 months looking at PW/Capel/Tudeley. Therefore draft policies do not specify the proportion of affordable housing to be provided at these strategic sites. SB also provided detail on the types of affordable housing.
- Query with regards to disabled standards in new housing. <u>Post meeting note</u>: final adjustment made to Housing for Older People policy in Draft LP (Policy H9):
- --- all affordable housing to be to Building Regs Part 4 M(2);
- --- where a need for fully wheelchair adaptable housing has been identified in the parish or ward, at least 5% of housing units on 20+ dwellings should meet wheelchair housing design standards;
- --- this has been updated on presentation slides (distributed with this email).

 Concern with regards to the allocation of gypsy/traveller site at Capel and Paddock Wood – SB confirmed that this has been discussed with the Town Council and is to accommodate a single family with local ties.

4 Programme and broad timetable moving forward

Discussion was had on future meetings and how best to conduct the meetings and agree membership and working arrangements over the course of the production of the masterplan.

SB stated that his preference would be a multi-disciplinary consultancy but welcomed input from around the room in terms of experience from elsewhere, preferred approaches etc.

Question if the masterplanning work will be complete by the Reg 19 consultation? – SB confirmed that it was anticipated that it would be well underway and handed out a slide with the programme and broad timetable for work going forward. SB also confirmed that the Pre-Submission version of the Local Plan is programmed to go to Full Council in July 2020 for agreement to undertake Reg 19 consultation (August – September 2020) with submission before end of 2020. He also stated that the Council will firm up its view on CIL and whether to progress with it by end of 2019

Some concerns were raised with regards to Southern Water – noted that they are not at the meeting. SB explained reasons why, and confirmed the commitment to produce a masterplan and SE/SB provided an update on the meeting that was held at the beginning of July with SW and a commitment to work more closely in the future. Some developers stated that previous experiences of masterplanning have not been without problems - more frequent working groups meetings are beneficial and that procurement for funding be started asap- concern over requirements for OJEU make the timetable longer for doing this. Discussion was had on the different ways of working and examples shared landowners appointing consultants and funded it/ consideration of if developers procuring the work themselves could be quicker and cheaper and concern over costs if developers are already producing assessments for their own sites. Was suggested that could have a steering board with various bodies represented (from those present today) – the make up of the board would be key. SB confirmed that he is keen to reduce costs and not delay the process but needs to ensure that it is carried out in the appropriate way following due process and so will need to consider it further and discuss with the relevant groups within TWBC. If the decision is that a Board be established, it would need to have a range of stakeholders on it and to be clear on the Terms of Reference and scope of the Board and group. SB to establish **ACTION**: SB to consider appropriate means to procure masterplanning, and to corporate establish corporate agreement on this matter before next meeting. Post meeting agreement note: SB confirms that timetable of internal boards and working groups allows for on this. TWBC have taken external advice on the matter - will update at next procurement meeting. approach before next Post meeting note: please refer to STR/CA1 (page 154) and STR/PW1 (page meeting 163) of Draft Local Plan for policy wording for masterplanning at these sites. 5 Discussion on Paddock Wood/Land East of Capel PW Town Council detailed that a masterplan previously promised for PW for the 900 houses allocated in the Site Allocations Local Plan 2016, did not come to fruition and that a masterplan for the proposed sites needs to be in place before any construction starts, as all the infrastructure being in place. SB confirmed that intention is that a Supplementary Planning Document would be in place and any planning applications will be assessed against it. SB reiterated his preference for a multi-disciplinary approach in particular for issues such as transport and flooding. SB provided an update on the flooding work carried out by JBA consulting on behalf of TWBC and that this should be used as a starting point for further work. Vicki Hubert gave an update on the transport work currently being carried out on behalf of TWBC (supported by KCC) by consultants SWECO. As above under point 5, was discussion suggested that the housebuilders

around the table today could commission the work themselves, working together and agree who to commission etc rather than use TWBC's consultants, but would work closely with the Council as could probably do this without going through OJEU.	ACTION
However it was also recognised that this could potentially cause problems in terms of public perception	
Discussion with regards to the town centre of Paddock Wood and the viability of the current centre to accommodate any future development was held – needs to be considered further and operators in the town centre need to work together.	
6 Discussion on Tudeley Garden Village	
A discussion was had on the Tudeley village and the following points were made;	
The promoters of Tudeley Village stated that they will be carrying out a consultation on the masterplan for Tudeley village sometime between the Reg 18 and Reg 19 consultations.	
Feelings were expressed that however the process is undertaken, there is likely to be opposition from Capel residents, and that such residents felt there would be no benefit for Capel and Five Oak Green.	
Query that considering how close Capel is to Tonbridge, it would have been good to see a representative from Tonbridge and Malling Borough Council at the meeting today. SB confirmed that T+M have been aware of the proposal for a considerable period of time, and will be invited to future meetings.	
Query over the scope of the masterplan for Tudeley village and how it will be linked to the Paddock Wood/Capel work/masterplan – for example in relation to transport.	
SB confirmed that Tudeley village will be considered as a separate settlement so would not expect it to be part of the masterplan but the promoters of this site would sit on the wider steering group and that there would be links between the two. Others felt that there is a big difference between the proposals and that Capel PC would need to work with PW TC on that proposal, but Tudeley village is different.	
Promoters of Tudeley confirmed that there proposals are much influenced by the concept of Poundbury and wanting to reflect it in the proposals – a walkable community is very much the aspiration. Others queried this approach – how realistic are the proposals – people will need a car etc. It was agreed that the promoters would have a discussion with Capel Parish Council outside of this meeting to discuss further.	
Query over whether a rail halt could be delivered as part of the proposals at Tudeley. SB confirmed that TWBC had raised this with Network Rail but currently had indicated that it could not – he felt that this requires political pressure to move forward.	

Discussion with regards to school provision – KCC confirmed that they felt that

the location for the proposed secondary school is in the right location to meet demand and that it would be a comprehensive, non-selective school and explained the process.	
7 Actions and next steps

	 In response to a question in relation to reference to Compulsory Purchase Order, SB confirmed that was intended that CPO powers would be used as an "unblocker" rather than aspirations for TWBC to acquire large swathes of land and to deliver the strategic sites itself; There was considerable discussion about the potential way in which "masterplanning" could be undertaken. David Banfield and others (including David Huggett) suggested an overarching framework, with a series of masterplans sitting beneath these; Was also various discussions as to how the infrastructure planning would relate to the masterplanning of Tudeley, and particularly in relation to road access. SB was clear, as set out in the Draft LP policy, that no decision had been made on the position of the highway link from land East of Capel/PW to the east; Further discussions were held regarding the relationship of the various proposed Allocation policies in the DLP for PW and land at East Capel to one another, and how these would be tied in with an overall masterplan for the settlement; It was agreed that detailed representations were to be made in the consultation period on the DLP: SB confirmed the timetable for the consultation, namely that it would be starting on 27th September 2019 and was scheduled to run for six weeks. 6.	Discussion on procurement of masterplanning consultants

3.	Local Cycle and Walking Infrastructure Plan - PJA Led by Ben Coleman	
	Ben introduced PJA, the consultant behind the Local Cycle and Walking Infrastructure Plan (LCWIP) for the borough, in particular connections between Tonbridge, Paddock Wood and Royal Tunbridge Wells (RTW).

These are mainly focused in RTW and consider the possibility of reducing the impact of through-traffic on residential streets. The focus is on dividing residential areas, surrounded by main road networks or train lines, into cells. The methods can be reasonably cheap, including signage and installing planters, as seen in many town's efforts to make streets less busy in light of Covid-19. Also looking to apply to PW

2) LCWIP

Tunbridge Wells already has a LCWIP in place, which was funded by the Department for Transport (DfT). This piece of work is an expansion of it, looking at the existing town in Paddock Wood. Although the plan does not go into detail on the technical design, it will provide design recommendations via a series of proposals around strategic walking and cycling improvements. The LCWIP is a live document, which can be updated. It is currently in Stages 3 and 4, whereby existing conditions are being reviewed and focus is primarily on Paddock Wood

3) Inter-urban routes

The inter-urban routes are those within the triangle between Tonbridge, Paddock Wood and RTW, and they explore the feasibility of joining up these settlements with their localities. The main method for exploring these is by calculating the Propensity to Cycle (PTC), which uses 2011 census data to map commuting trips. This straight-line analysis shows origins and destinations of where it expects people to be cycling to and from. This is mapped against existing road network, providing the basis of for the inter-urban routes. So far, the desktop review has been completed, and some site audits have also been undertaken. PJA is now sifting through the preferred alignments, and is continuing to review Paddock Wood, using an audit tool on site.

Cllr Mackonochie asked if the complex topography between the settlements would be factored in the methodology and also whether restricting car use in rural areas, where public transport is unavailable, would be feasible. Ben explained that topography is something they reflect on when using the matrix of prioritising. He also explained that in London there is a strategic road network than can absorb the additional trips – and acknowledged that in a more rural setting it is different, however the focus will be on smaller trips that could be walked or cycled, where they are currently driven.

Cllr Mackonochie also asked whether offline routes through fields would be considered for horse riders. Ben explained that it would depend on the routes being considered, as up until now they had not yet been factored in, in terms of design. He explained they are likely to be site specific, and some of the PRoW would not be proposing lots of cycling infrastructure as they need maintenance so fit for all purposes. Hannah confirmed this was something that would be considered by the newly appointed consultant for the wider masterplanning of the strategic sites (Paddock Wood, Capel and Tudeley).

Cllr Hamilton asked whether routes to and from East Peckham have been considered, and whether mobility scooter use had also been included. Ben explained that it is something they will be looking at in their next site visits, however explained that all aspects being considered work in tandem (cycling, walking, mobility scooters), and ensuring dropped curb and suitable surfacing, for instance, are provided to ensure all modes of transport can safely access

the routes. Steve Baughen also emphasised the importance of the inter-urban routes and how they play a key role in moving forward with the masterplanning work around the strategic sites.

lan Bailey asked if further information on what has been agreed for the KCC funding on active travel was available. Vicki Hubert (KCC) explained that she did not have details of this but will provide highlights to be added to the minutes. Steve Baughen added that a new 20 mph limit for areas of RTW and pedestrianisation of the High Street, and additional work on Camden Road, are some of the main projects that have been funded.

Cllr Fenton enquired whether there had been any more consideration to Capel within the LCWIP, due to traffic concerns. Ben explained that they have looked at routes from Capel into Paddock Wood, and from Five Oak through to Paddock Wood, and still need to visit routes from Tonbridge through to Tudeley. They are working closely with developers on site and will have a network of routes, therefore Capel will be considered within these.

Sought to ensure the policy is flexible in so far as it is not fixed but sets out what can be achieved at the sites. Key elements highlighted through work integrated in policy in terms of sustainable garden settlement.

Evidence base will be made available in public domain ahead of Regulation 19.

The next steps are to start progressing with the Supplementary Planning Documents (SPD) to embed further details and requirements.

SB added that an updated Local Development Scheme (LDS) will be issued, probably by mid-February, which will not propose any changes to the timetable of Local Plan but will have a timetable for the SPDs.

Cllr Williams asked why the PSLP does not take account of developments currently going ahead in Paddock Wood, or the plans to development leisure centre or schools. SB explained that the plan start date is 2020, so sites permitted already, such as Mascalls Court Farm (Persimmon site), are not shown as new allocations as they are being built out as present. Similar to Knights Wood development at RTW. The date of 2020 post dates the grant of planning permission. They have been factored into the considerations of the Local Plan, highlighted in the supporting text (population projections, traffic considerations etc). The one site included is the Church Farm proposal, because it is integral to have access through the site to the land beyond it. Mascalls Farm is included as a separate allocation as Phase 2 is pending a decision.

Regarding population growth projections and education need in Paddock Wood, HY explained that the two schools in the plan are in addition to what is permitted as Mascalls Court Farm, over plan period of up to 2038.

- Given that the Draft Local Plan was now publicly available (given that it had been attached to reports to Planning and Transportation Cabinet Advisory Board, and Cabinet) there were questions raised, clarification sought, and discussions held regarding different aspects of the policies in the Draft Local Plan;
- TWBC explained that it had given significant consideration to different approaches to procuring masterplanning work, had taken advice from external organisations, and had made a clear decision that TWBC would lead on the commissioning of the team/consultancies for overall infrastructure masterplan and relevant frameworks/masterplans for land at east Capel/Paddock Wood.
